CONDITIONS OF FORTNIGHTLY DIRECT DEBIT MEMBERSHIPS

TERMS AND CONDITIONS:	Terms and conditions are in accordance with the Direct Debit Request Service Agreement
PAYMENT:	Continuing Direct Debit payments are made in advance for the coming fortnight from an approved credit card or bank account. Fees are deducted on the Thursday of each fortnight. If the Thursday falls on a public holiday, the deductions will be made on the first business day thereafter. Fortnightly fees are non-refundable.
TERM	Debit memberships are ongoing fortnightly payment memberships
CHANGES TO MEMBERSHIPS	All changes to memberships must be made in writing/e-mail. (Membership amendment forms are available from reception if required). As the centre must contact you in writing/e-mail to inform you of any changes to prices and terms & conditions, the centre must be informed of any changes of address
DEBIT REJECTION & PROCESSING FEES	When direct debit payments are rejected by the bank, the sum of the declined transaction will be rolled over into the following fortnight's payment and an administration fee of \$15 will be added. Any rejection in the processing of your membership will incur a fee of \$15 per rejection.
SUSPENSION	You may suspend your membership for a minimum of one month up to a maximum of six months. A suspension fee of \$7.50 will be debited from your account in lieu of the standard fortnightly payment. You must give notification (including a return date) in writing/e-mail to reception. Suspensions will not be made retrospectively.
CANCELLATIONS	You may cancel your membership at any time by completing/authorising a cancellation form during operating hours.
ALTERATION NOTIFICATION	You will be given one month's notice in writing/email of any price alterations. You will also be informed in writing/email of any changes to the terms and conditions outlined in this application. The new conditions will become effective immediately after the date outlined in the correspondence
CONCESSION RATES	All full time students and pension card holders will be eligible for the concession rate
LOST CARDS	There will be a \$5.00 fee charged for the replacement of lost cards, which will be a one off payment added to your direct debit.
